



## Protection of the Environment Operations (POEO) Public Register

The Minister appointed Water NSW as the Regulatory Authority for the purposes of section 61 of the *Water NSW Act 2014* to exercise regulatory functions.

Clause 8 of the Water NSW Regulation 2020 requires Water NSW as the Regulatory Authority to maintain a register that details each environment protection notice issued by the Regulatory Authority under the *Protection of the Environment Operations Act 1997* (POEO Act). The register is to be made available to the public on the Water NSW internet site. Section 308 of the POEO Act also requires Water NSW as the Regulatory Authority to keep a public register and include details of each penalty notice issued and convictions in prosecutions under the POEO Act.

The public register provides details of each environment protection notice and penalty notice issued by Water NSW as the Regulatory Authority, and the Sydney Catchment Authority before its abolition on 31 December 2014.
