

## Report annual licensed and BLR water take where no meter is required

To comply with clause 250 of the *Water Management (General) Regulation 2018*, this form is to be completed by all water users whose work(s) don't require a meter to record annual licensed and basic landholder rights (BLR) water taken by a licensed work. You are required to report your usage even when it is zero.

Please complete separate forms for each work approval.

### Returning completed forms to satisfy reporting condition

Report your usage by sending pages 2 and 3 to us within 28 days of the end of the water year (30 June each year). Please complete the form with a black/blue ink pen and use BLOCK letters. You can also type directly in this form. Once completed, please print, and sign the form.

Monitoring, recording, and reporting conditions applicable to water licences require some personal information in compliance with the relevant legislation and to provide you with our services. If you choose not to provide the requested information in this form, required for compliance with your licence conditions and to provide you with our services, you may not be able to take water as your licence may be suspended or cancelled, and, more generally, you may be in breach of the Water Management Act 2000. ### Offences and penalties

It is an offence, under section 344 of the *Water Management Act* 2000, to make a statement that you know to be false or misleading in, or in connection with, this application.

A corporation found guilty of an offence against section 344 is liable to a penalty not exceeding \$2.002 million. An individual found guilty of an offence against section 344 is liable to a penalty not exceeding \$500,500. An access licence or approval may be suspended or cancelled under the *Water Management Act 2000* in certain circumstances. These include if the holder of the licence or approval is convicted of an offence under that Act.
